Our purpose is to restore hope to those dealing with life challenges, resurrect lost self-esteem, and re-ignite the desire to become the best version of themselves. We do this by teaching in eight dynamic one hour classes the power of thinking and provide a clear understanding of how life choices are made. The program is now reaching a diverse population of individuals. This population includes the homeless in transition, incarcerated individuals seeking re-entry, parolees in transition to the community, and others struggling with life challenges.

(6) Your Life's Next Chapter.(7) The Significant Life. (8) The Recipe for Greatness. WHERE PROGRAM IS TAUGHT - The Real Life Skills program is taught to a diverse population. This population includes the homeless in transition at 2 locations, Inmates in prison seeking early release at 4 prison facilities, a location serving low income families, and at our corporate office for parolees returning into the community. TEACHING ACCOMPLISHMENTS - The program was taught to 559 students versus 507 and 479 in 2017 and 2016 respectively. The teaching staff has 5 certified facilitators. TEACHING HOMELESS IN TRANSITION - The program is taught at the San Diego Rescue Mission and Connections Housing(Path).There are many factors that make it difficult for the homeless to overcome; depression, low-self-esteem, addictions, loss of income, etc. Real Life Skills is dedicated to help the homeless with our program. The beginning of this restoration project must be internal. They must be reminded and convinced they already possess incalculable value and this is what we do by introducing them to an untapped resource, THEIR OWN MIND. The number one skill in Real Life Skills is thinking! All successful individuals understand that right thinking is the key to a meaningful and productive life. We believe the homeless in shelters have taken a first step in demonstrating their desire for a better life. We build on this desire in our classes that are designed to restore self-respect and dignity, rebuild confidence, and develop a purposeful life. TEACHING PAROLEES IN TRANSITION TO SOCIETY - When men, women and teenagers go to jail or juvenile hall for making a bad choice(s), what is our responsibility? We pay hundreds of thousands of dollars to house, feed, clothe and guard them. Are they redeemable? Can they learn from their mistakes and become model citizens? Yes, we believe many can! In 2018, we taught our program to parolees for an organization known as the HealthRight 360 Stop Program. They receive funding from the California Department of Corrections and Rehabilitation.They engaged us, under contract, to teach Real Life Skills to a group of men who were serving life sentences. They are in a sponsored safe house for 3 months during the transition back into society. Our program is mandatory, taught once a week in the evening so it will not interfere with their needs to find jobs. In 2018 The program was taught to 74 parolees. TEACHING INCARCERATED INMATES SEEKING EARLY RELEASE. The program is taught at the prison facilities. The facilities included East Mesa Re-Entry, Las Colinas, Detention Center, WestCare, Core Civic, and The Girls Rehab Facility. Our program is being taught to inmates that are in a re-entry program who are selected for early release, usually within a year. In eight life changing lessons we teach this population that failure can be a blessing in disguise, designed to re-route them to a better destination. We teach them that adversity can make them stronger, wiser, and better if they will look at their situation with a positive mental attitude. We teach them how to think successfully, and if they persevere they will become a better version of themselves. We teach them the next chapter in their lives is the most important chapter and how they can create a significant and successful future.TEACHING LOW INCOME FAMILIES RECEIVING SUPPORTIVE HOUSING. Our program is taught to Section 8 downtown residents at the San Diego Housing Commission Achievement Academy in November. Future sessions are planned. As a result we were invited to teach our program in February at the new Envision Center. This center is located at the San Diego Metro Center operated by the San Diego Workforce Partnership. TEACHING APARTMENT MANAGERS OF AFFORDABLE HOUSING. Our program was taught to a group of 20 resident managers of Wakeland Housing Corporation.The program was held at the Atmosphere Apartments in downtown San Diego. A course was also taught to the residents living at the apartment. TEACHING ADULT EDUCATION. This program is taught at the Corporate Office and IS open to the public for those facing life challenges and seeking more joy, peace, and happiness. HOW DO WE KNOW THE PROGRAM WORKS? Our students tell us on their class evaluations and verbally about the transformation that takes place in their minds and lives. Further evidence is from written class evaluations, class participation, student testimonials, feedback from caseworkers, and enthusiastic support from the agencies we serve and available to view on our web site at: www.reallifeskills.org. TIME TO GIVE THANKS -We are grateful to God for the opportunities we have to serve and help an increasing population of people suffering from homelessness, extreme stress, poor decisions, broken lives, health issues, job losses, drugs, financial hardships, and lack of resources. We are grateful to the San Diego Rotary club for their \$5,000 donation to help us reach more homeless people.We are thankful for al our contributors that have provided the needed financial support.
